RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

In consideration of being allowed to operate a golf cart within the confines of the Clearwater Lake Regional Park as per the RM of Lacadena bylaw #05-2025, I hereby release the RM of Lacadena and the Clearwater Lake Regional Park Authority, and their officers, directors, employees, servants, agents and any other appointees or representatives from all responsibility for bodily injury, property damage, liability, costs and expenses of every nature and kind how so ever arising, whether as a result of accident or negligence from or in consequence of the operation of my golf cart within the confines of the Park aforesaid.

I further release, remise, discharge and agree to save harmless the RM of Lacadena and the Clearwater Lake regional Park Authority, and their Officers, Directors, Employees, Servants, Agents, and any other appointees or representatives from all claims and rights of action which may arise as a result of the operation of my golf cart.

I am fully aware that there is a risk of personal injury to myself and to others in the use of golf cart and fully accept the risk of potential harm to myself or other, also the risk of damage to property which may be suffered by myself or others. I accept all legal and physical risks related to the operation of my golf cart and waive and relinquish any right I may have to sue for damage, from any cause including negligence on the part of the RM of Lacadena and the Clearwater Lake Regional Park Authority, and their officers, directors, employees, servants, agents, and any other appointees or representatives from and against all claims of loss, injuries, or damages sustained by any person including myself or damage to property and all expenses including solicitor/client legal costs, incurring or arising from the use of my golf cart as here in before provided.

The terms here of shall be binding upon me, my heirs, executors, administrators, and assignees (including others to whom I may lend my golf cart) as well as any Corporation and its officers, directors, shareholders, successors, and assign on behalf I exercise this **RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.**

GOLF CART REGISTRATION

A golf cart registration is a complementary administrative rule to RM Bylaw #05-2025 which authorizes the operation of a golf cart on roadways and trails of Clearwater Lake Regional Park.

The fee for registration of the golf cart is \$25 for the original issue of a license plate. The fee for a seasonal renewal and provision of an updated sticker for the plate is \$5. The term of the registration is from May 1st to September 30th in any calendar year.

1. The numbered plate provided to the owner/lessee of the golf course must be affixed, and kept affixed to the rear of the cart in a manner as to be visible, at all times.
2. The applicant further agrees that all operators of their golf cart must abide by the RM Bylaw #05-2025 and the CLRP administrative bylaw for the use of golf carts in the park.
